

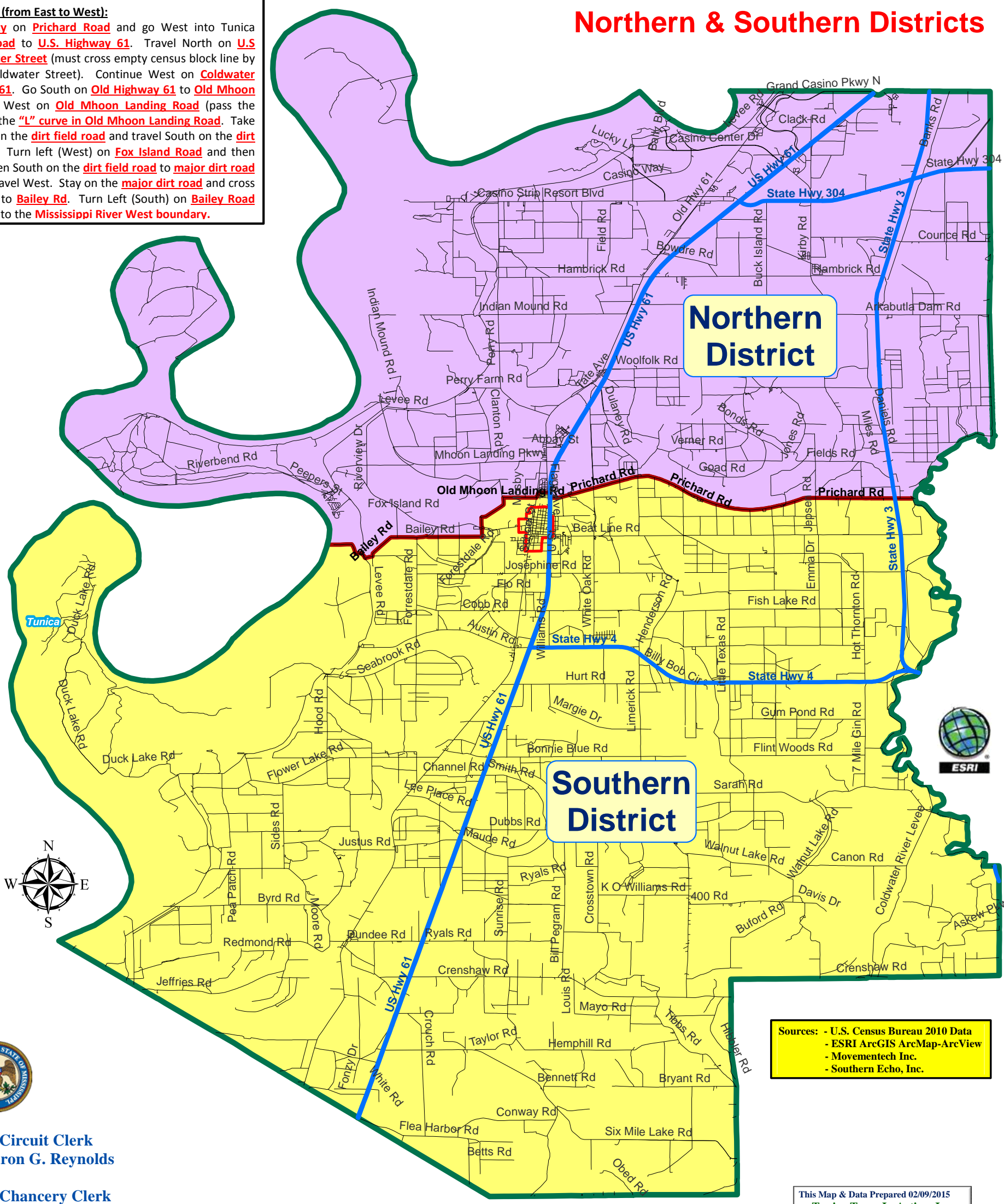
# TUNICA COUNTY VOTING DISTRICTS

## Redistricting Plan 7c+ Amendments

**MAP #6**

**Plan 7c+  
Justice Court & Constable  
Northern & Southern Districts**

**Boundary Dividing Line (from East to West):**  
Start from **Tate County** on **Prichard Road** and go West into Tunica County on **Prichard Road** to **U.S. Highway 61**. Travel North on **U.S Highway 61** to **Coldwater Street** (must cross empty census block line by Bud's Snack Bar to Coldwater Street). Continue West on **Coldwater Street** to **Old Highway 61**. Go South on **Old Highway 61** to **Old Mhoon Landing Road**. Travel West on **Old Mhoon Landing Road** (pass the Sheriff Department) to the "L" curve in **Old Mhoon Landing Road**. Take a left at the "L" curve on the **dirt field road** and travel South on the **dirt field** to **Fox Island Rd**. Turn left (West) on **Fox Island Road** and then Right on **McClain Rd** then South on the **dirt field road** to **major dirt road** and make a right and travel West. Stay on the **major dirt road** and cross the ditch on westward to **Bailey Rd**. Turn Left (South) on **Bailey Road** and go across the levee to the **Mississippi River West boundary**.

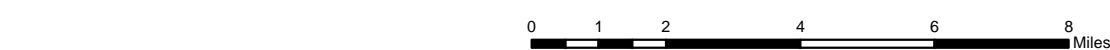
